# HWF Scholarship Project

Welfare The Human Foundation is committed to promoting education and creating opportunities for individuals and communities. The visionary founders of the HWF believed that "education is the key to unlocking opportunities and a tool of mobility because socio-economic it enhances productivity as it is associated with skill and knowledge of higher wages" thus designed scholarship Project aimed at providing financial assistance to deserving students and empower them to achieve their academic goals.

Under this initiative the HWF provides scholarships, mentorship programs, and other resources to support students in their academic pursuits.

The scholarship program is open to students who have excelled academically, demonstrated leadership potential, and are from economically low-income group. The scholarship funds cover tuition fees, books, and other related expenses. The scholarship is based on the financial need and merit of the applicant.


The goal of the program is empowering individuals to realize their full potential and make a positive impact on the world. In the last one and a half decade the Foundation has left measurable qualitative impact on society. Thousands of students could complete their higher degrees with its scholarships support.



# Working Area

The inclusion and exclusion of both the region and candidates for the project intervention have been thought through on several parameters. Presently the scholarship project is active in 13 states. The rationale of selecting those states is their socioeconomic backwardness. In total 500 scholarships have been determined annually for 13 states of which 305 scholarships are earmarked for 5 states only. These states are Assam, Bihar, Jharkhand, UP and WB.

These are the poorest states of India as well as most educationally backward. Many districts are at the bottom of education and poverty. In the light of recent NITI Aayog's 2021 baseline report on National Multidimensional Poverty Index the backwardness of these states is much visible.



When we look at the poverty index these states are the worst performer. On multi-dimensional poverty index released by NITI Aayog half the population found to be near poverty line. This poverty results into their educational backwardness. Therefore, the HWF renders its helping hands to those who need support. However, with limited resource only selected few could be helped therefore a selection criterion was developed to find the best deserving candidate.

## **Student Selection Process**

Exclusion of a needy candidate is hapless feeling for the organization and the applicant. Practically, not all applications can be selected for variety of reason. The foremost reason is the resource limitation. Therefore, a selection criterion has been designed to select the most deserving. Two basic criteria were opted: Merit and Need. To ensure that there is no gender discrimination, scholarship numbers are equally divided for both the gender. The weightage in the selection procedure was distributed in ratio of 30: 70 where 30 marks is to determine candidate's need. The need and merit are determined in the flowing two categories:



Figure 1. Total Scholarship Distribution and Students 2016-24




In the assessment period between 2016 and 2024, the HWF through its scholarship program made qualitative impact in the lives of thousands of students. During this period, as shown in the above graph, 2310 scholarship under undergraduate and postgraduate categories have been awarded. The recipient students were 1734 in total.






# Scholarship Distribution Program

Empowering the Next Generati Leaders through Education








In this chart state wise numerical distribution of scholarship is shown. The bars are sequenced in descending order. At the two ends of the axis are the lowest and highest recipient of the scholarship. West Bengal, Assam and UP are the major beneficiaries. There are reasons for this. The allocated scholarship quota is the highest for these states corresponding to their demographic data. Second, among all the selected states, these are the most economically and educationally backward states.




### Figure 4. Gender wise Scholarship Distribution



Gender-equitable education system empowers both men and women and promotes a proposer society. Nobel Laurate Amartya Sen, architect of the concept of Human Development, stated that "if we continue to leave vast sections of the people of the world outside the orbit of education, we make the world not only less just, but also less secure". This insecurity is rooted in education deprivation reenforced by societal economic barriers. To minimize those barriers the HWF equally supports both the gender and allocated its scholarship equally between them. In the beginning the gap was in favour of boys. Thereafter the girls have outnumbered the boys in terms of receiving scholarship award.

### Figure 5. University wise Scholarship distribution 2016-2024

Its observable in the illustration that around 25 per cent scholarship goes to central universities. Majority of the central University scholarship are availed by postgraduate students. Further the central university reach is limited to 6 universities namely Jamia Millia Islamia, Aligarh Muslim University, Delhi University, MANUU, BHU and IGNOU

# Figure 6. Courses Supported through Scholarship 2016-24





# Prof. K.A. Siddique Hassan Scholarship



In January 2022, Vision announced a new PG scholarship program in the name of our Founder GS, and the chief architect of the Vision project Prof. K.A Siddique Hassan. The scholarship is a yearly program intended at supporting young talents from the most marginalized communities in the country. Target beneficiaries of the scholarship are PG students with potential leadership qualities who are in their first semester studying in premier institutes in the country.

Scholarship applications are open to all disciplines and from across the country. The awardees are provided with Rs. 30,000/- as scholarships.

In the last two academic years a total of 132 scholarships were awarded.

In terms of gender parity 68 girls were awarded the scholarships while 64 boys received the scholarship. Education, Law and social sciences students received the most scholarship.
